ORDER DENYING DEFENDANTS' MOTION FOR SUMMARY DISPOSITION

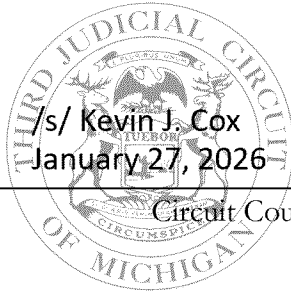
