WHEREAS, the parties require additional time between the present and the date of the Final Approval Hearing to give notice to the Class and an opportunity to opt out, object, or file a claim;

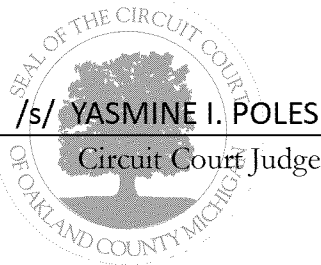
IT IS HEREBY ORDERED:

3. A hearing (the "Settlement Hearing") will be held before this Court on December 1, 2021 at 1:30 pm to determine whether the proposed settlement between Plaintiffs and Defendant, on the terms and conditions provided in the Agreement, is fair, reasonable and adequate and should be approved by the Court, to determine whether a final judgment should be entered dismissing this Lawsuit with prejudice, and without costs, and to determine whether to award attorneys' fees and expenses to Class Counsel and the amount of such fees and expenses.

2. All other provisions of the Preliminary Approval Order remain in effect.
